YARD SALE APPLICATION



Yard Sales require a Permit from Mount Airy Town Hall. Apply for the permit at least two days before the start of the sale, but no more than seven days before.

A \$5.00 fee is required for the permit. You are limited to four (4) sales at the same location during any twelve (12) month period.

Yard Sales are permitted on in residential areas.

Yard Sales are permitted by Town ordinance for the convenience of Mount Airy residents who have a need to dispose of their own, used, personal belongings.

Yard Sales are not for the purpose of the direct sale of new or used merchandise obtained for the purpose of resale.

The sale of new or used merchandise in business, professional or industrial zoned areas requires the appropriate business license from Mount Airy Town Hall.

Yard Sale permits are available only to residents of Mount Airy.

Several Mount Airy families may get together for a multi-family Yard Sale at one location.

RULES FOR YARD SALE SIGNS

- Signs can be no larger than four (4) square feet (example 2x2).
- Two signs may be placed on the property where the sale is conducted.
- If the sale is not on a main thoroughfare, directional sign(s) may be placed on other private property with the property owner's written permission by filling out the signature form.
- Signs may not be placed on right of way, power poles, traffic sign poles or street sign poles.
- Signs must be removed within 24 hours of the end of the sale.
